Truman Canter's name appeared in the 1800 Tax List of Wythe County, Va.

Tazewell County Order Book # 1( 42) Deed from Truman Canter and Cynthia, his wife, to Lewis Milam.

1783, Henry and Truman given land as " assignees" in Hampshire County, Va.

( now Hardy County, W.Va.)

1799 - signed petition for forming of Tazewell County from Wythe County, Va.

Signers: Henry Canter, Trueby ( Truman) Canter, Thomas Canter, Thomas Sr. Canter,

John Canter, James Canter, & Samuel Harris, ( father of Cynthia Harris, wife of Truman).

The 1793 Wythe County, Va. Personal Property Tax List has these

CANTER names listed: TRUMAN CANTER - Tithes / 1 Horses / 3 , Henry Canter- Tithes, 1 / horses, 2, and John Canter / Tithes 1, horses, 1. / 1799

Monroe County, W.Va. Personal Property Tax List, Canter, Truman 1- - 1.

The 1783 tax list for Tazewell with a Truman and Henry Canter I have no clue.

I don't seem to have a Henry Canter listed that would have been old enough to be taxed. This Henry at the earliest would have to be born around 1763,

probably before. You just have to set down and go through all the names when you find something and subtract the dates and guess. I use a 20 year rule

like at least age 20 to marry and have land, etc. May have been a brother to Thomas. We don't know his parents or brothers and sisters. I think we need to

study the info we have and make a migration chart for each. Note sometimes you find them in another county but they did not move the county line moved

instead. It gets complicated and sometimes I wonder why I started this. I

don't think I realized the time, effort, and money that would go into it. But still now I am determined to give it my best effort. GLAD TO HAVE YOU AND THE
